

INFORMATION FOR MEDIA

During January-July 2023, the total trade volume of operations with securities on the Baku Stock Exchange amounted to **9,777,082,198 AZN** and compared to the same period of the previous year, **19%** growth was registered.

As a result, compared to the same period of the previous year, the volume of primary market for corporate securities increased by **27%**, and the secondary market volume of corporate securities increased by **39%**, while repo operations increased by **61%**. Furthermore, the repo market for corporate securities has seen **9 times** increase compared to the previous year.

As of the last trading day in June 2023, the capitalization of the Baku Stock Exchange amounted to **4,900,144,490 AZN** and compared to the last trading day of last year, **20%** growth was registered.
