

INFORMATION FOR MEDIA

During January-September 2023, the total trade volume of operations with securities on the Baku Stock Exchange amounted to **15,909,046,023** AZN and compared to the same period of the previous year, **74%** growth was registered.

As a result, compared to the same period of the previous year, the volume of primary market for corporate securities increased by **28 %**, and the secondary market volume of corporate securities increased by **49%**, while repo operations increased by **150%**. Furthermore, the repo market for corporate securities has seen **10 times** increase compared to the previous year.

As of the last trading day in August 2023, the capitalization of the Baku Stock Exchange amounted to **4,995,678,475** AZN and compared to the last trading day of last year, **22%** growth was registered.
