

INFORMATION FOR MEDIA

During January-October 2023, the total trade volume of operations with securities on the Baku Stock Exchange amounted to **19,452,794,779** AZN and compared to the same period of the previous year, **86%** growth was registered.

As a result, compared to the same period of the previous year, the volume of primary market for corporate securities increased by **21 %**, and the secondary market volume of corporate securities increased by **18%**, while repo operations increased by **195%**. Furthermore, the repo market for corporate securities has seen a close to **9 times** increase compared to the previous year.

As of the last trading day in October 2023, the capitalization of the Baku Stock Exchange amounted to **5,000,904,144** AZN and compared to the last trading day of last year, **22%** growth was registered.
