

## INFORMATION FOR MEDIA

During January-November 2023, the total trade volume of operations with securities on the Baku Stock Exchange amounted to **21,836,902,192** AZN and compared to the same period of the previous year, **76%** growth was registered.

As a result, compared to the same period of the previous year, the volume of primary market for corporate securities increased by 4 %, and the secondary market volume of corporate securities increased by 6%, while repo operations increased by 197%. Furthermore, the repo market for corporate securities increased by 450% compared to the previous year.

As of the last trading day in November 2023, the capitalization of the Baku Stock Exchange amounted to **5,000,904,144** AZN and compared to the last trading day of last year, **22%** growth was registered.
