

INFORMATION FOR MEDIA

The total volume of securities transactions on the Baku Stock Exchange between 01.01.2022 and 31.12.2022 amounted to **14,947,984,521** AZN, a decrease of only **2%** compared to the corresponding period of the previous year. As a result, compared to the corresponding period of last year, an increase in the trading volume of state securities by **14%**, in corporate securities by **93%**, which includes: primary market by **17%**, secondary market by **405%**, and repo operations of corporate securities by **2694%** was observed. Also, a **30%** decrease in total repo operations was recorded compared to last year. As of the last trading day of December 2022, the capitalization of the Baku Stock Exchange amounted to **4,193,278,402** AZN, a decrease of only **4%** compared to the corresponding period of the previous year. In 2022, the number of corporate securities placements (excluding mortgage bonds) on the Baku Stock Exchange increased by **36%** to **45** compared to last year, and the number of mass corporate securities placements (excluding mortgage bonds) increased by **47%** to **34**.
